Green Bay Exposition Services will accept crated, boxed or skidded materials beginning February 8th, 2023 to the warehouse address. To avoid additional after deadline charges, materials must arrive by February 16th, 2023. If materials are sent to the warehouse location after February 21st, 2023, an additional \$50.00 handling fee will apply.
